Introduction

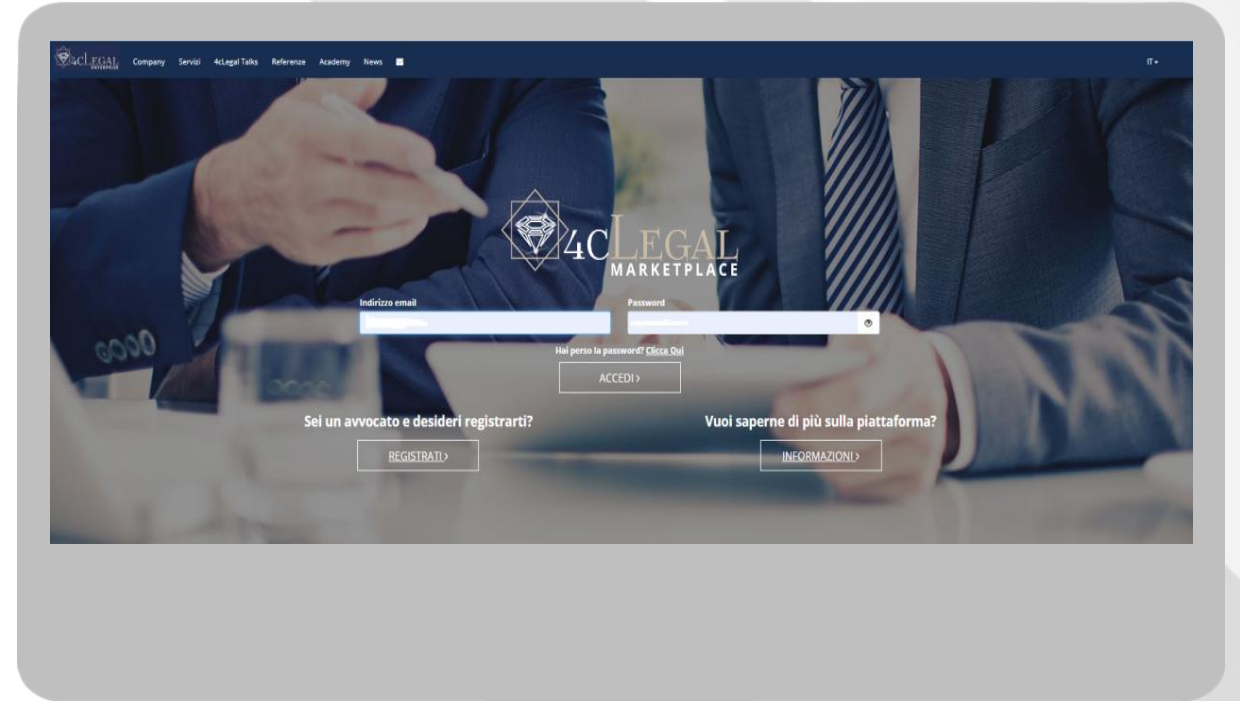
The **4cLegal** platform, **established in 2014**, has evolved by supporting the **transformation** process of Italian and international **legal procurement**.

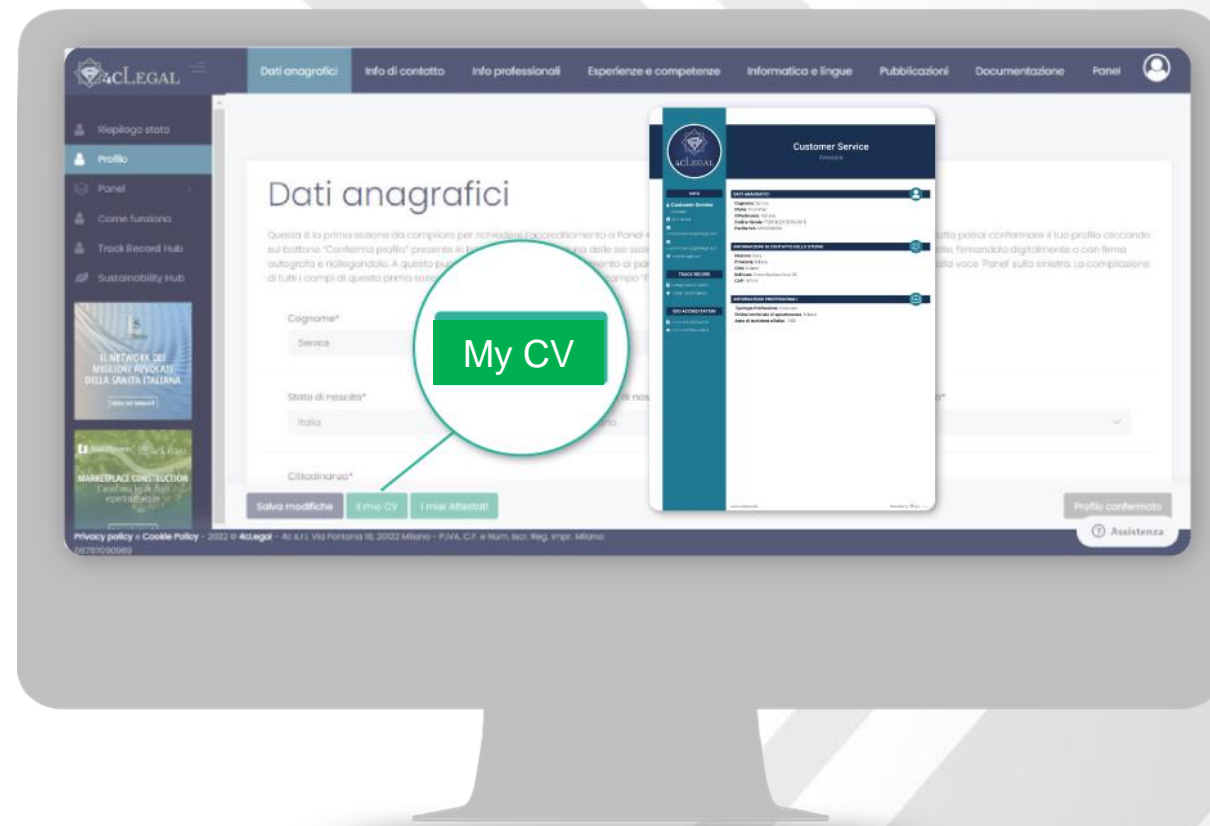
Complete your profile for an up-to-date CV

- Other relevant professional skills

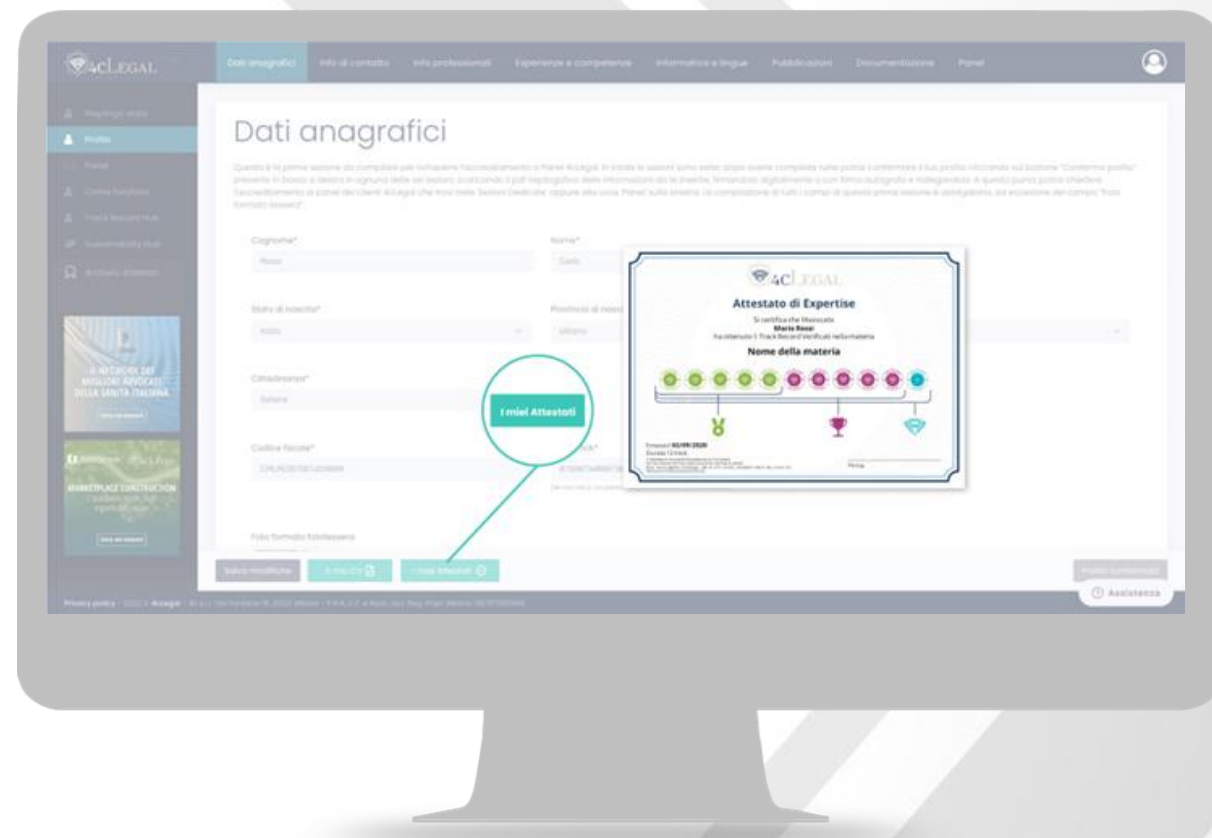


Accredit and enhance your skills

In addition to signaling the validation of the specific **track-record** through the application of the **Quality Badge**. 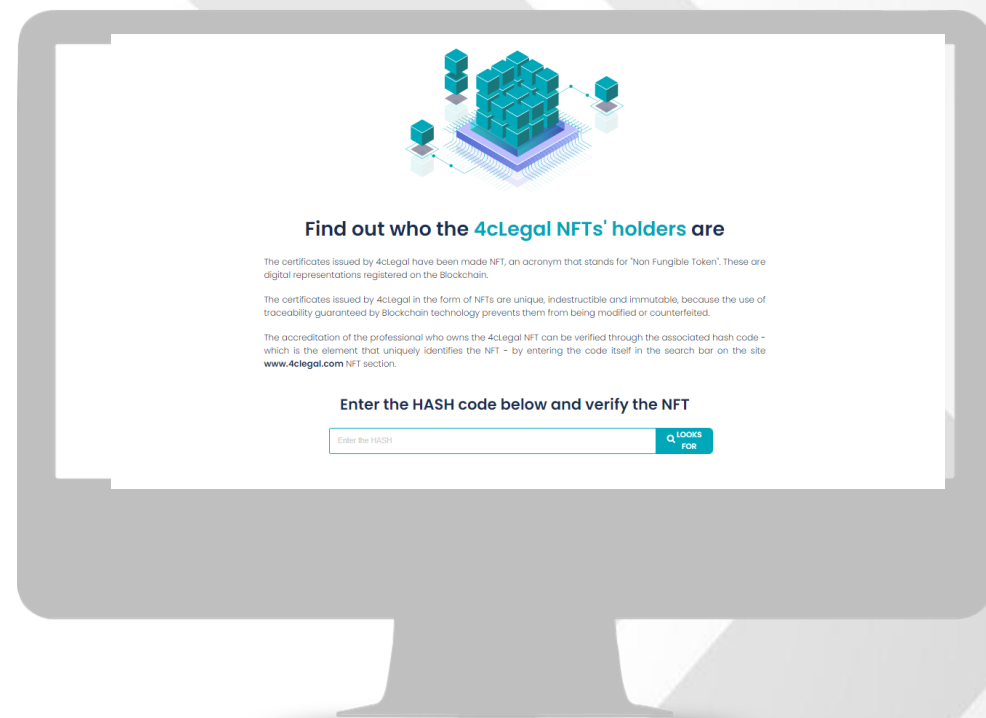
Have authentic and verifiable attestations

4cLegal Attestations can also be issued in the form of **NFTs**.

The use of NFTs lends **greater robustness** to the information contained in the attestations and allows verification of its veracity and validity to any interested party: simply enter the associated **hash code** on the [dedicated page](#) to view the **attestation holder's data**. Should the attestation be expired or false, the search would produce no results.

Moreover, we highlight that the service is able to guarantee the **right to deletion of the data subject's personal data (Art. 17 GDPR)** associated with the certificate.

his is because, 4cLegal has created a **database** that associates a **hash code** with the first and last name of the person to whom it relates. In fact, should the data subject request the deletion of his or her personal data, the request could be properly processed by deleting the first and last name in the 4cLegal database and thus removing **the link between the hash code and the data subject**. For the effect, no one would be able to relate the data in the NFT back to the individual to whom it relates.

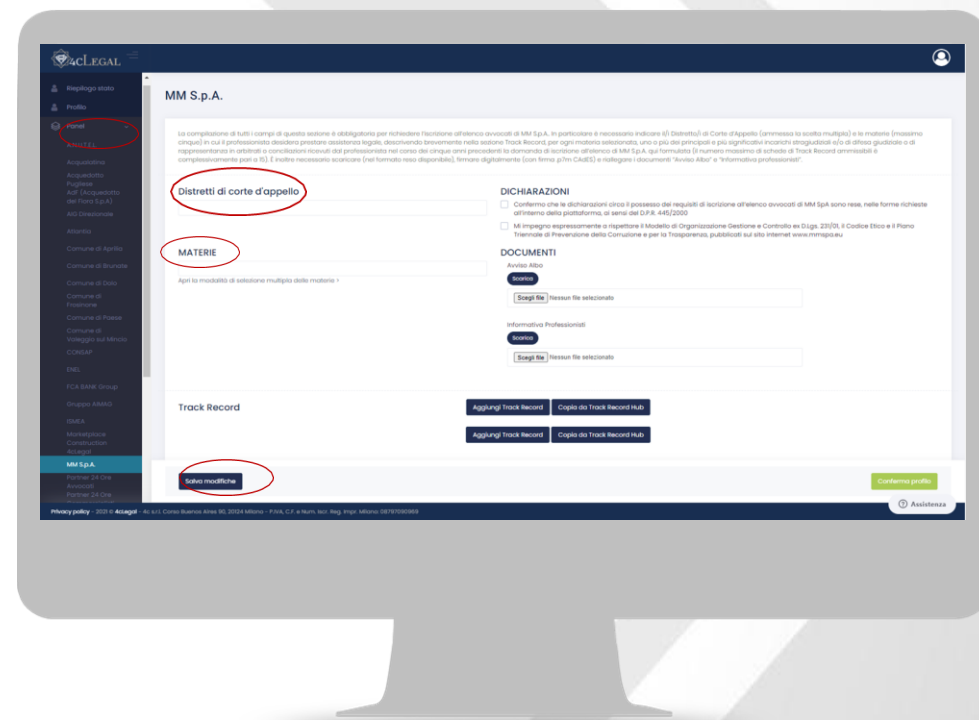


Business development opportunities
